**Matters Arising from September Minutes**

**4. Parish Plan LV's email of 29<sup>th</sup> September 2020**

**LV** had emailed on 29<sup>th</sup> September to advise he was going to go back to his team for further comment. **WN** responded to that email that the PC had already discussed and adopted the amended Plan and thanked **LV** for his time and advised that the plan was on Parish website. **BDC** have a copy if they wish to refer to it and it is on the website for new residents.

**5. The Mere clearance**

The work has been completed. Some reeds remain and just need to keep an eye on these in case they start to encroach. Frizzels did an excellent job.

**6. Footpaths and Drains in The Street**

NCC have now attended to cut back the verges to widen the footpath, overhanging hedges are still an issue in places. They have also attended to deal with the drains by Octavia House which will hopefully resolve the standing water problem

**7. Noise nuisance next to Back Lane – email from resident dated 22 September 2020**

**WN** spoke to the farmers concerned. We recognise this is an annual issue after harvest and that there will probably be young people that congregate on the back lanes next year as they have for many generations. **WN** considered that there is not much to be done as it is private land but recognised that residents would be dissatisfied with this. However if the issues escalate and people come from outside the village then we will once again discuss with the landowners and do our best to prevent it.

**LB** noted it is a rare event. However, if it became a real nuisance the PC would have to think differently about it.

**8. Date for clearance around the Mere**

The land on the perimeter of The Mere needs a good clearance. It is currently too wet and it was agreed to put on the Agenda to discuss in January for a date in Feb or March

**9. Concern over children crossing between parked cars near school**

**DE** contacted the Clerk to ask for a letter to the school as concern had been raised about children crossing between parked cars.

**WN** felt that the school is probably aware and it is the parents parking on the “keep clear” that causes the problem. The PC have addressed this previously. Clerk will flag with the school. Concern is still HGV's having to get past the school on a blind bend. There is a dropped kerb to

allow people to cross as safely as they can which we would encourage people to use.

10. **Sam2 speed sign rota**

The clerk has re-done the rota and distributed this to the 8 volunteers who have kindly agreed. The more volunteers we have the less often they have to move the sign. **WN** agreed he would be happy to go on the rota.

11. **Volunteer to paint shelter at the Mere**

**WN** said that he would take on the painting of the Notice Board
