6. Exception sites and email (22/04) from James Heaton for discussion

It has been confirmed that the necessary reports have not been provided as they should have been by the Developer before the building was demolished regarding land contamination. MCA advised the Clerk to let Mr Curtis Planning Enforcement Officer know that HSE have directed us to Environmental Health. MCA will speak to Capita and The Contaminated Land Officer and suggested the Clerk will contact EDP on behalf of the Parish Council. The main concern is effect on parishioners health given the vicinity to residents and the school and reassurance is necessary.

Member of the public raised his concern about asbestos and the risk to health.
